PROTECTIVE GLOVES FOR FIREFIGHTING

FLAME AIB 659

5-finger glove in waterproof full grain cowhide leather, thickness mm 1.1, with 60-minute liquid penetration time, gauntlet cuff in split leather (18 cm) thickness mm 1.4, adjustable by Velcro closure. Reinforcement on the back of the glove. On the lower part of the palm is applied a protective shoulder split leather vein patch. Lined with quilted aramid fleece 270g/sqm. All stitching in Kevlar thread 50/3.
