Jacket in 54% viscose FR, 20% polyamide, 20% wool, 5% aramid, 1% antistatic fibre 375 g/m² dark blue fabric. Reflective bands on sleeves, chest and back. Central closure with Velcro and snap buttons covered externally in fabric. Mandarin collar. Four flap pockets with Velcro fastening. All seams in Nomex 70/3 yarn.

Colours on request: orange, red, midnight blue, grey, dark grey.

Variant on request: Reflective bands on biceps, chest and back, with zip fastening, code V3TWBFV.
